**AMENDED ENVIRONMENTAL BOND** – Upon a motion made by Trustee Parisi and seconded by Trustee Priestley, it was,

**RESOLVED** (**#2021-01-14**), to sign the amended 2006 Environmental Bond that transfers the money from the Pocket Park at Secatogue Avenue and Front Street to 5 Corners Redevelopment. The Village is responsible for \$12,500 and Nassau County to pay \$137,500 for a total of \$150,000.

  - LOSAP went up 12% for 2020
- Building Department:
  - 37 Potter Street is able to get a building permit. They need to work out differences with the Nassau County Fire Marshal.
  - 20 Merritts is moving forward Sod went down and the retaining wall is being worked on. An arborist is reviewing trees that may be compromised, after getting their opinion the developer will remove trees if recommended. Homes are 95% complete, 4 are sold.
  - Robbie Lee is out of the state. He fired the steel company and is waiting for steel to be manufactured.
  - Towing company response is slow.
