2023/2024 Budget Resolution

RESOLVED, to adopt the 2023/2024 Budget as presented with a net budget of \$4,292,743 with the following appropriations: Reserve for Debt to be appropriated of \$66,450. The total tax levy of \$4,226,293 is an increase of 1.95% and within the New York State allowable tax cap limit.

FURTHER RESOLVED, to certify the tax shares or base proportion percentages as follows: Homestead 65.2879% and Non-homestead of 34.7121% and the tax levy breakdown as: Homestead \$2,759,258 and Non-homestead of \$1,467,035. Corresponding tax rates are \$2.506012/1,000 in assessed value for Homestead and \$4.981378/1,000 in assessed value for Non-homestead.
