**MISC. ROADWAY IMPROVEMENTS CONTRACT** – Upon a motion made by Trustee Priestley and seconded by Trustee Parisi, it was,

**RESOLVED** (#2021-05-22), to approve Roadwork Ahead, Inc. as the successful bidder on the Miscellaneous Roadway Improvements Requirements Contract for one year in the amount of \$1,797,000 after analysis and recommendation of Village Engineer Savik and Murray. This contract can be renewed for two additional years with the agreement of both parties.

The following topics were discussed:

- Ax throwing at Lithology:
  - Kevin Cain, Manny and John Ardito spoke for Lithology. They are asking to host a mobile ax throwing league.
  - It will be enclosed within a fence, waivers are signed and a company runs the event.
  - o 16 people are in the Lithology league.
  - o A small ax is thrown 12 feet. The event is 2 hours long.
- Farmingdale Thrift Shop proposal:
  - Nick Turbendian clothing boxes will support veteran's organizations.
  - o Village Attorney DeBellis is working up an agreement.
- Discussed changes in CDC, New York State and Nassau County Department of Health regulations regarding vaccinations and masks.
- Brad DeMilo asked if the Village was having the Pops concerts this year. Will it be a smaller number of days? He suggested a 4<sup>th</sup> of July concert. Trustee Priestley and Mayor Ekstrand are in favor of trying the concerts but Trustee Parisi is not in favor of it. The rest of the Board is okay with it.
- Fire Department:
  - o Looking at pricing to replace all windows at Village Hall.
- Building Department:
  - The former tanning salon is changing hands, more details to follow.
- Highway Department:
  - Special thanks to Kenny Tortoso for refurbishing the historic Broad Springs sign on Merritts Road.
