Mayor Ekstrand opened the meeting at 8:10 PM with the pledge of allegiance.

ANNOUNCEMENTS – Mayor Ekstrand made the following announcements:

- Announce the sale of tax liens will be held on March 12, 2013 at 11:00 a.m.

PRESENTATION OF PROCLAMATION TO DEBBIE PODOLSKI – Mayor Ekstrand thanked Ms. Podolski for all her effort and dedicated work to the Village and Chamber of Commerce and presented her with a proclamation on behalf of the Village.

NEW HIRES/PROMOTIONS – Upon motions duly made and seconded it was unanimously,

RESOLVED (#2013-170),

- To approve the hiring of Lorraine OøShea as an Account Clerk at a salary of \$32,000 per year.
- To approve the hiring of Matthew Kilbridge as a Laborer in the Highway Department at a salary of \$30,000 per year.
- To approve the promotion of John Langon from Laborer to MEO in the Highway Department at a salary increase of \$4,000.
- To approve the hiring of Ralph Fargardo as a part-time Parking Enforcer in the Code Department at a salary of \$12.00 per hour.
- To approve the increase in hourly salary for Parking Enforcer, Ed Zena, from \$12 to \$15/hr.

RESOLVED, to issue 60 taxi permits upon review.

VESTED CLASSIFICATION HEALTH CONTRIBUTION - for all employees who have left or will be leaving employment from the Village of Farmingdale in a Vested Status (Classification 7) the following applies to their contribution rate to the cost of the NYSHIP

Health Insurance plan. Upon a motion made by Trustee Ryan and seconded by Trustee Parisi, it was unanimously,

RESOLVED (#2013-181), to change the contribution for Classification 7 ó Vested ó employees who left the Village prior to retirement ó the employee will be contributing the maximum allowed by law currently defined as follows:

- Single plan ó 50% contribution
- Family plan ó 50% of the cost of the single plan <u>plus</u> 65% of the difference in costs between the family and single plans.

HIRING LAW FIRM OF NAPOLI BERN - Upon a motion made by Trustee Ryan and seconded by Deputy Mayor Christiansen, it was unanimously,

RESOLVED (#2013-182), to retain the firm of NAPOLI BERN RIPKA SHKOLNIK & ASSOCIATES, LLP to represent the Village in connection with its claim for potential damages resulting from the ground water contamination of well 1-3 as per the attached resolution and retainer agreement.

CODE VEHICLES - Upon a motion made by Trustee Ryan and seconded by Trustee Barrett, it was unanimously,

RESOLVED (#2013-183), to approve the purchase of two Code Enforcement cars, Chevy Equinox, from Hoselton Chevrolet as the lowest responsible bidder for a cost of \$ 21,743.21 each.

DPW DUMP BODY – The following resolutions were for the purchase of a new truck dump body for a net cost of \$1.00 after the trade in of other surplus equipment.

Upon a motion made by Trustee Barrett and seconded by Trustee Parisi, it was unanimously,

RESOLVED (#2013-184), to approve the replacement of dump body by R.W. Truck Equipment with a flatbed amending the P.O. with Syosset Truck at a cost of \$3,851.

Upon a motion made by Trustee Ryan and seconded by Trustee Barrett, it was unanimously,

BEAUTIFICATION – Deputy Mayor Christiansen thanked all the volunteers for their hard work. She stated that she knew they didnøt have lights on Main Street, but the sacrifice was made due to Town of Oyster Bayøs and electrical contractors work load to make necessary repairs due to Hurricane Sandy. She went on to say that even without the lights the Village looked wonderful.

GOOD AND WELFARE

- Mr. Diurno, Fairview Rd., asked about the vacant business local law to improve the look of Main Street. Mayor Ekstrand stated that the Board forgot but will work on it.
- Mr. Carosella discussed the following:
 - Asked if the school district can paint on the empty store windows. Mayor Ekstrand stated that he will have the Downtown Revitalization Committee look into it.
 - Stated that many businesses didnøt have holiday decorations and asked if the Village can send a letter next year reminding the store owners of the coming holidays.
 - Asked for the status of the Hookah Bar. Mayor Ekstrand stated that they did not have a liquor license.
 - Mentioned that there is a missing street sign on the corner of Hill Rd. and Merritts. Superintendent Fisch stated that he would have it replaced.
 - $\circ~$ Asked if the bike store was closed. Mayor Ekstrand responded that it was out of business.
- Mr. Ezzo, Prospect St. had the following items to discuss:
 - \circ $\;$ Thanked the DPW crew for the clean up after the storm.
 - Mentioned that the pigeons were back on Main Street. Mayor Ekstrand replied that it was an ongoing problem.
 - Stated that a parent from the St. Lukeøs school blocked his driveway for 10 minutes. Mayor Ekstrand asked the Village Administrator to send Code Enforcement to clear the problems.
 - $\circ\,$ Asked about the water proposals. Mayor Ekstrand stated that the work session on January 28th was solely dedicated to the discussion.
- Mr. Wilson, Normandy Dr. asked if the Village looked at auctions to purchase the vehicles since the Village got such bargains in the past. Mayor Ekstrand stated that the vehicles purchased at auction were prone to repair.
- Mayor Starkie asked who the Downtown Master Plan committee was and what do they do? Deputy Mayor Christiansen stated that Chuck Gosline heads the committee and they are tasked with marketing Main Street. The committee also has some merchants on it.
- Mayor Starkie asked for clarification on the Bartone project. Mayor Ekstrand explained that Bartone was looking to put a smaller mixed use building on the site

where the hotel was proposed. Mayor Starkie stated that we worked so hard to keep the density spread out and the hotel would not add to the density. He stated that it was just greed to agree to have this much density in the area.

- Ms. Podolski stated that she didnøt know that the hotel was no longer in the plans and asked if the new plans would be research as extensively as the hotel was. Mayor Ekstrand stated that plans for the project have not been presented to the Village.
- Mr. Diurno asked when the Board was going to tell the Village that the hotel was not going to be built. Mayor Ekstrand stated that the Board just found out and Superintendent Fellman stated that the plans have not been submitted.

EXECUTIVE SESSION, upon a motion duly made and seconded, it was unanimously,

RESOLVED, to move to Executive Session to discuss personnel and legal matters.

Upon a motion duly made and seconded, it was unanimously,

RESOLVED, to reconvene the meeting.
