RESOLVED (#2021-01-17), to acknowledge the return of the 2020/2021 tax roll and warrant and report of unpaid taxes (See attached list) pursuant §1436 of the Real Property Tax Law of the State of New York.

TREE REMOVAL – Upon a motion made by Trustee Priestley and seconded by Deputy Mayor Barrett, it was,

- Towing/Auto Body shop on Rte. 109 needs to make an application for an 8' wall/fence.
- Other restaurants that have recently gotten building permits have little or no activity.

• Highway Department:

- o Pole and light were replaced in Moby Way.
- o Ready for upcoming storms
- o Installing a dog waste station on Eastern Parkway
- o Routing sweeping and cleaning of the Village

• Water Department:

o Bids are due for the new water tank on February 17th.

• Code Department:

- o Badges are done for Village personnel.
