Paver issue on Cherry Street residence nearing resolution. Both Sterlling Green and Robby Lee project proceeding. No issues with either project. The parking lot at CVS will be repaved in September. Tom Reddy is organizing all new rental inspections and inspections of public assembly locations in compliance with the new rental local law.

From Ken Tortoso: DPW weekly work assignments for the past 2 weeks:

- 1# Movie Night was cancelled due to inclement weather on July 18.
- 2# Crews have been watering every day.
- 3# Crews have been preparing everything for the Movie Nights and Music on Main.
- 4# Going to start painting stop lines in all lots and in the residential areas in the coming weeks.
- 5# Stapleton has been in removing trees and will be back for stumps next week.
- 6# Town of Oyster Bay has been in repairing street lights.
- 7# Fleet maintenance crews have been busy keeping our fleet up and running along with doing repairs on code cars and Fire Dept. vehicles.
- 8# Sweeper #2 is back in service.
- 13. Water Department: Water Tower Construction continues with few punch list items remaining. Cell providers organizing contractors to remove old equipment from the old tank and install new on the new tank. Including NCPD microwave. Two are completed and one is partially done. They will all finish by the time that the tank is scheduled to come down in September. AOP installation by Philip Ross is complete and testing to meet health department requirements is complete. SCADA system design for this new system is underway by Philip Ross Industries coordinating with Bob Holzmacher. Three million awarded to VOF in Gov. Hochul's budget for Improvements WIIA Grant. This funding will be applied for in the near term as paperwork is coming from PRI to make application for reimbursement funding. Dan to follow up with PWGC for reimbursement. A meeting was held with PRI to get update on Plant 1 & Plant 2 Construction underway by PRI at plant 2 location with GAC building excavation, foundation and installation of GAC tanks completed. Pipe installation to connect into the system is near completion with cut in's to main trunk lines to be done just after peak pumping season. New WIIA Grant application has been submitted to the State by PWGC. PWGC following up on required testing to secure funding from legal settlement.

From John Falbo: Recent work the past week:

1# There is a light at the end of the tunnel for startup of the AOP/GAC at Eastern Parkway. The series of samples taken on Friday as flushing of the GAC tanks was completed and results have passed the required test. Data has been submitted to NCDOH for permission to put the well and treatment facilities into full service. We are working with PRI install new SCADA system to operate the new treatment facilities.

2# Drainage at Well 1-3 repaired.

3# Preliminary quarterly sample report for Well 2-2 at Ridge Road for this quarter and month shows a lower trend on PFAS PFOA, The next sample will be taken at the end of July for that well.
