**SURPLUS VEHICLE** – Upon a motion made by Trustee Priestley and seconded by Trustee Addeo, it was unanimously,

**RESOLVED** (#2021-10-19), to approve the sale of a 2002 Dodge Utility Vehicle (Rack Truck) VIN 3B6MF36542M309785 that had been previously declared surplus, as the truck's engine would stop working for no apparent reason. Initial repair was to the electronic system but the same problem persisted and Security Dodge in Amityville had diagnosed the issue as the truck needing new engine heads at a cost of approximately \$8,000 with no guarantee. This truck's age, condition and repair amount make the truck from both a safety and age/value perspective inappropriate to spend the \$8,000 for a potential repair without a guarantee. The truck was advertised in the Farmingdale Observer and received one proposal from Ricardo Amaya Rodriguez in the amount of \$400. The truck is inoperative and otherwise would be sold for scrap at 11 cents/pound and have to be towed to a scrap facility.
