Mayor Ekstrand opened the meeting at 7:10 p.m.

Anthony Bartone, Phil Cerrone and representatives from MoCa Asian Bistro addressed the Board to clarify parking and Public Hearing requirements for retail space in Jefferson Plaza. The Public Hearing on the application of Starbucks will be held on December 7, 2015.

Commissioner Schumeyer advised the Board that new members have been accepted into the Fire Department and there is a need for ten additional pagers. The cost will be \$5,000 which was not included within the budget. The funds will be appropriated from the Fire Department Capital Reserve. This matter will be voted upon at the Board meeting on November 2nd. Commissioner Schumeyer thanked the Board for the new air conditioner in the kitchen. Administrator Harty advised that he is awaiting information from Chief Ryan Tortoso for the new chief's car. Once received, bid documents for the vehicle will be issued.

Members of the Planning Board and Zoning Board of Appeals were in attendance. Issues that have arisen in the past were discussed, i.e., incomplete applications, deviations from code and lack of understanding by some applicants. A concerted effort will be made to make certain members are given complete packets; incomplete applications will not be accepted.

The Board has determined that 2' x 3' signs announcing Public Hearings for commercial spaces will become a requirement. This matter will be placed on the Agenda for the Board meeting on November 2^{nd} .

Building Superintendent Fellman advised that the Public Hearing for GTM Sports Bar will be held on November 2nd. The Board requested that Mr. Fellman contact Premier Building regarding the outside appearance of their premises and Toretta Associates with regard to the expiration of their Special Use Permit.

Administrator Harty advised the Board of the following:

- Crack sealing is being done, as needed, on all streets and parking lots in the Village;
