### • Fire Department:

#### • Building Department:

- o 37 Potter Street is applying for a waiver for a sprinkler system and is waiting for a decision from the state.
- Robbie Lee Steel is being delivered tomorrow and the foundation has been backfilled.
- Fence issue with Sam Glass has been resolved installation in the near future.
- Towing/Auto Body at Rte. 109 corner site has been cleaned up need to investigate wall.
- 20 Merritts Road no activity but a new project manager has been assigned by the developer.
- Trustee Addeo asked if a resident had a permit to install a pool at Duane St.
   & Clinton Ave. Superintendent Fellman will look into this.

## • Highway Department:

## • Water Department:

- The new booster pump was delivered with incorrect bolt pattern on coupling and needs to be replaced by the manufacturer.
- o The new tank is being readied for bid.

## • Code Department:

- O Joe Ramos is relocating to South Carolina and will be leaving the Code Department in mid-December. The Board of Trustees and Village Attorney thanked him for his dedicated service and wished him and his family a happy and healthy retirement.
- o Diane Menig is taking photos of employees and will have ID badges made.

#### • Other:

- Wedding approved on the Village Green & Gazebo for December 6, 2020.
   All Covid-19 protocols must be followed to meet the Governor's requirements.
- The Holiday Tree on the Village Green has lights and is illuminated. There will be no tree lighting ceremony due to Covid-19.
