FOR PUBLIC HEARING:

<u>Radius Map:</u> This must be drawn to scale and show the names of abutting or adjacent owners, and their section, block, lot number and lot dimensions, all within a two hundred (200) foot radius of the <u>outer perimeter</u> of the subject property.

On a separate sheet of paper list the names and addresses of the property owners covered by this 200 foot radius.

When the application has been received by the Planning Board/BOT and paperwork is found to be correct and in order and the requisite fee paid, the application will be calendared for public hearing. All costs incurred for the review of the application and the public hearing (i.e. legal notice, attorney fees and court reporter) will be charged back to the applicant. The Building Department will mail the applicant a copy of the public notice as it will appear in the newspaper. The applicant must mail a copy of this public notice to all of the property owners listed on the 200 foot radius map. Each notice must be sent by certified mail, return receipt requested and postmarked NO LATER than ten (10) days prior to the date of the scheduled public hearing.

When the mailing has been completed, the applicant must submit to the Building Department a notarized Affidavit of Mailing at least two (2) days prior to the date of the hearing, giving the name of the person who mailed the notices, the post office where they were mailed and the date they were mailed.

The applicant shall conspicuously post at least one (1) poster, said poster must not be less than three (3) feet by four (4) feet in size along each street frontage of the property which is the subject of the application at least ten (10) days prior to the date set for the public hearing. Such poster shall contain the following information:

1) A brief explanation of the proposed site plan approval request.

2) That a public hearing will be held before the Planning Board at a specified date, and the time and place with regard to the proposed hearing.

3) Said poster must remain in place until the public hearing has been completed and must be removed no later than seven (7) days thereafter. The applicant, or applicant's agent, shall verify that said poster is still in place on a daily basis and shall promptly replace said poster should it be removed or defaced.

NOTE: If application pertains to work already commenced, no further work is to be performed until a decision has been rendered on the application. Applicant must set forth the date work commenced, the date work was halted or completed (if applicable) and complete details as to what work was performed and/or is still to be accomplished as of the date the application is submitted.
